### **OUR MISSION:**

To engage in protecting and restoring the treasured natural habitats of the Forest Preserves of Cook County and to enhance the outdoor experiences of all communities.

We will do this by encouraging and administering private gifts to further the Forest Preserves' mission and goals.



Dear Friends,

It has been a productive year for the Foundation. We set to work implementing our first strategic plan, and are excited to share with you the progress we have made in each of our four goal areas:

**Identity and Brand:** Our goal is to strengthen identity and increase brand visibility. We made progress on this goal with the help of a generous gift from Leo Burnett. We now have an updated logo and new messaging that we're excited to unveil this holiday season. We also increased our visibility in the press with commentaries that were published in the Chicago Tribune and Crain's Chicago Business.

**People and Programs:** Our goal is to increase access to the Preserves. This will expand the diversity of visitors to the Preserves and deepen their commitment to the Preserves' health. Toward this goal, we made \$250,000 in grants in 2016. While this amount is comparable to the last year's giving, we were able to allocate a greater proportion of our total grants to the Forest Preserve District. For instance, in 2014 we made several grants, totaling \$80,000, to community-based organizations that participated in Conservation Corps programming in the Preserves. In contrast, this year we granted \$50,000 to one community-based partner, the Student Conservation Association, for the express purpose of supporting the Conservation Corps. We believe that this grant aligns more closely with the directives of our strategic plan.

**Resources and Relationships:** We are diversifying our funding and expanding community and donor relationships. This year, we engaged more families and residents, which led to an increase in memorial gifts. We continued working with companies that encourage their employees to volunteer in the Preserves, and we also welcomed new corporate donors, including BP; Recreational Equipment, Inc.; Waste Management, Inc., and Allstate Corp. We strengthened relationships with our returning corporate sponsors at our 5th annual Conservation Cup golf outing, which met its fundraising goal of \$175,000. This is 75 percent more than the Cup raised in its inaugural year.

Leadership and Leverage: We are expanding and enhancing our board of directors. After we thanked Stuart (Stu) Cohn for his gracious service as chair, he assumed the role of board secretary. We welcomed Tom Livingston as our new chair. Under his leadership, we began implementing our first strategic plan. We also welcomed two new board members: John Atkinson of Willis Group Holdings and Leslie Fenton of PricewaterhouseCoopers. Our bylaws also were updated to formally include on the Board the General Superintendent of the Forest Preserves, which will ensure that our work is consistently aligned with the priorities of the Forest Preserve District of Cook County.

We are energized by the successes of this amazing year of growth and opportunity, and look forward to carrying this momentum into 2017.

## **OUR STORY**

The Forest Preserve Foundation, founded in 2006, had its genesis in the belief that tax dollars would need to be supplemented in order to realize the visionary goals of the Forest Preserves of Cook County.

In 2012, the Foundation actively started raising private funds, hosting the first Conservation Cup, its annual golf benefit. That year the Foundation granted \$3,500 to the Forest Preserves.

Because the Foundation's mission so clearly resonated with local businesses and community leaders, it has been able to continually increase its grant making with their support. In 2015, the Foundation awarded nearly \$250,000 to support opportunities that allow families and children from a diversity of backgrounds to enjoy the forest preserves. Foundation grants underwrite youth conservation leadership programs, camping courses, gear rental programs and capital improvements that welcome and engage visitors to the preserves.

The Foundation looks back on another strong year of grantmaking in 2016, with total lifetime grants in excess of \$685,000.

This year the Foundation began implementation of its first strategic plan, designed to set it on a strong and steady course and well positioned to meet its primary goal: increasing access for all to the Cook County Forest Preserves.



## PROGRAM HIGHLIGHTS


Picture first-time camper Myla lighting up at the sight of a peppered moth. Or imagine her eyes bright with wonder and delight as she takes an evening hike through the woods near Camp Sullivan. It is in moments like these that nature comes alive — and the Forest Preserve Foundation's mission is reaffirmed.

The Foundation funds and supports programs designed for youth and families to connect with nature and become empowered through new experiences, introduction to skills and a lasting commitment to the health of the Preserves. These programs educate participants in an outdoor classroom like no other. Participants gain knowledge and skills that will inspire and motivate them to make sound choices that will enhance the environment for years to come.

### **CAMPERSHIPS**

On a moonlit night in late June, Damara Saddler and her four kids camped under the stars at Camp Sullivan. It was their first overnight, outdoor camping experience. Saddler said she wanted "to see how it is to sleep outdoors." Her two young daughters, especially, were all too happy to try a night in a tent.

Wild Indigo Nature Explorations, a group that organizes free outdoor field trips and activities in southeast Cook County, facilitated the family's introduction to camping. Wild Indigo's outreach fellows run the overnight camping excursions.

The fellows must first participate in the Forest Preserves' Camping Leadership Immersion Course (CLIC), which certifies and trains them to lead the campouts. The Forest Preserve Foundation provides financial support for CLIC.

This year the Foundation granted \$25,000 to the Forest Preserve District of Cook County for family camperships, or scholarships for camping. The support ensures that no family is prevented from experiencing camping because of financial challenges. The program provides reduced rates, camp gear rental, meals, and guided outdoor activities.



### CONSERVATION CORPS

The Foundation continued its support of the Student Conservation Association and the Chicago Conservation Leadership Corps Program with grants totaling \$100,000 grant this year. The program runs in partnership with the Forest Preserves of Cook County, Friends of the Forest Preserves and the Student Conservation Association.

During the six-week hands-on program, participating teens receive extensive and specialized conservation training from highly skilled field leaders before they are assigned to work on habitat restoration projects in the Preserves. They learn how to safely handle forestry tools, the proper and safe clothes to wear, and how to identify native plants. Their work mulching trails, removing invasive buckthorns and building small dams to control water runoff has a huge impact on the health of the Preserves.

"This was my second year with the program, and it has really helped me to stay open minded about jobs in the environmental and

conservation work fields," said Luigi, a high school junior. "Since I've joined the program, I've learned to work with different types of people and have gained many qualities that a leader exemplifies through team building exercises."

This year's overall program supported 70 high school and college students while providing employment experience, science education and an enriching summer. The Foundation's grant underwrote the expenses of 10 crew members and two leaders assigned to the Ted Stone Preserve.

### **CONSERVATION CUP**

The Forest Preserve Foundation held its 5th Annual Conservation Cup Golf Outing on Sept. 15 at the George W. Dunne National Course in Oak Forest. More than 170 golfers and guests enjoyed a beautiful day on the greens, all while helping to raise \$175,000 in support of the Foundation's mission and programs. 

### Connecting to the mission
