It is the Forest Preserve Foundation's signature fundraising event that supports:

- **Next generation environmental advocates** through paid summer internships that provide employment and leadership experiences for teens and young adults in the Forest Preserves of Cook County.
- **Climate change** mitigation through ecological restoration projects that return our natural landscapes to sustainable health.

What is the Conservation Cup's impact?

- Over time, proceeds have supported 500 youth conservation internships in the Forest Preserves: 53% from low-income communities, 66% African American and 11% Latinx.
- Helped restore more than 630 acres in the Forest Preserves as part of ongoing efforts to mitigate the effects of climate change.
