

## A Letter from Debra Walker Johnson, President & Executive Director



As I look back on 2021, I am reminded that we have much to celebrate. I joined the Forest Preserve Foundation as its new president and executive director during the first quarter. In addition to my taking my new role, we further supplemented our leadership with Jim Beck taking over the reins as Board Chair after four years of valuable board service. We also welcomed three remarkable individuals to our board of directors. I look forward to providing the leadership and vision to move the Foundation to the next level.

The impact of Covid-19 during the past year and a half has highlighted the importance of our work. We saw unprecedented levels of participation in outdoor activities at the Forest Preserves, as visitors sought peace and solace in nature during this time. Not only did existing visitors reinvigorate their engagement,

but new visitors discovered that the Forest Preserves provide a place for creating their own adventure right in their backyard.

Despite the ongoing challenges presented by Covid-19 variants, we stayed focused on our mission, granting \$326,898 in funding to support programs and activities at the Forest Preserves of Cook County in 2021. This funding enabled 166 youth to learn about conservation and earn money through internship opportunities at the Conservation Corps. It also supported the restoration of 293 acres of the Preserves in areas of the highest need, where invasive species threaten sensitive ecosystems and where habitats have been damaged.

We also celebrated the 10th anniversary of the Conservation Cup. Thanks to the generosity of our sponsors and partners, this year's event raised more than \$220,000, breaking the Conservation Cup fundraising record.

I am honored to have been chosen to lead the Foundation in this exciting new phase of growth. As we prepare for the new year, we look forward to working with our partners and supporters to champion new ways to engage outdoor participants. Together we will invest in making the Forest Preserves of Cook County accessible and welcoming to all residents.

This growth in use of the Preserves is wonderful news. It also means that the need for financial support to care for the Preserves is growing too.







- Trails require maintenance and improvement.
- Trail and other enhancement projects reduce soil erosion as well as improve visitor enjoyment of nature.
- Invasive species require removal, so that native species can thrive.

Invasive plant species like buckthorn, honeysuckle and barberry arrive unwanted in forest preserves from residential yards via birds' droppings. Removing these invasives allows native plant species to thrive, providing habitat for native birds, mammals and insects.

Logistical and cultural barriers to equitable access require remediation to benefit everyone.

Environmental, restoration and sustainability communities need and benefit from racial diversity, equity and inclusion. FPCC is addressing barriers so that everyone can enjoy nature.

## **CONSERVATION CORPS**Forest Preserve Experience

This five-week paid summer program engages high school students in rewarding conservation work and nature education experiences. Youth work in teams to gain job skills to prepare them for the workforce, while also having fun in nature. 

## **Chicago Conservation Leadership Corps**

This program is a paid five-week service-learning experience for high school students who work in teams throughout the Forest Preserves of Cook County. It teaches basic job skills while benefiting nature through hands-on service projects. We nurture and inspire the next generation to become lifelong advocates for nature. 

## RESTORATION

... Funding supported the restoration of 293 acres of the Preserves in areas of the highest need, where invasive species threaten sensitive ecosystems and where habitats have been damaged.

Ecological restoration is the process of returning landscapes to health using scientific knowledge and recognized techniques to create an ecosystem filled

with a diversity of native plants and animals.

## GRANTS AWARDED

## FOREST PRESERVES OF COOK COUNTY



## Sweet Woods \$136,923

This grant funded invasive species removal and regrowth treatment on 176 acres of woodland and 80 acres of wetland in Sweet Woods. This work is part of the ongoing restoration of Sweet Woods, the largest-scale restoration project in the Foundation's history.

## Restoration of Cranberry Slough \$35,700

Phase IV saw over 25 acres of tree and foliage thinning in Cranberry Slough, increasing sunlight and promoting native species growth on the forest floor. The Foundation has funded 350 acres of restoration at the 550-acre preserve.




## Restoration of Schubert Woods \$9,000

This grant provided for the restoration of 5.4 acres of oak woodland in Schubert Woods; more than double the project's original 2-acre scope. The site is a remnant of pre-settlement woodland ecology and a Forest Preserves priority restoration area.

## Spring Lake \$13,500

This grant provided 3.8 acres of invasive species removal along the Spring Creek headwater, restoring the Creek's riparian buffer and the adjacent wetland meadow. These improvements promote biodiversity and hydrological health at the headwater and further downstream

#### **Restoration of Sweet Woods**


### \$24,975
